# FishAbility Sports Club

## *Athlete Agreement & Code of Conduct*

1. Athletes are ambassadors of FishAbility Sports Club and shall maintain high standards of moral and ethical conduct. This includes self control, responsible behaviour, as well as consideration for others' physical and emotional well being, ensuring a safe and harassment – free environment.
2. Athletes must uphold the standards of fair play, and exhibit a high level of sportsmanship and team spirit and shall treat others with respect and expect to be treated with respect in return.
3. Athletes shall perform to the best of their ability and accept with pride the result that effort brings and be gracious in victory and defeat.
4. Athletes will accept the officials' decisions without argument; play with intensity but without hostility.
5. Athletes shall refrain from the use of profane, insulting, harassing, or otherwise offensive language.
6. All athletes shall agree that:
  - 6.1 Athletes shall not engage in behaviour that is unsportsmanlike, disruptive, disrespectful, harassing, abusive, racist, sexist, dangerous or criminal.
  - 6.2 They shall not possess or use any illegal drugs. The use of performance enhancing drugs is strictly banned.
  - 6.3 Athletes under the age of 19 will not possess or use alcohol or tobacco in any form during events or at any social activities connected with the event.
  - 6.4 Obey all Provincial and Federal laws, on alcohol consumption and illegal substance (drug) and tobacco use.  
Athletes 19 years and over will not possess or use alcohol in any form within the immediate area of an event, or competition site or between games played on the same day, and not in excess in the residence or accommodations.
  - 6.5 Respect all rules and regulations at competitive or visiting venues and facilities. This includes regulations and guidelines of the clean air policy and ban on smoking.
  - 6.6 Any damage to hotel rooms or other property shall be assessed to the account of the athlete.

A breach of any part of this code of conduct is sufficient grounds for an athlete to be withdrawn from an event and be sent home at their own expense.
